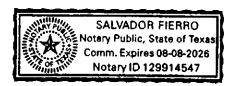

Pool Rules

Hours of Operation: 7:00 AM to 9:00 PM

The use of the community pool center is exclusively for residents in good standing of the Heritage Trails Homeowners Association and their guests.

All Monthly Assessments must be paid in full prior to use of the pool

- ❖ WARNING!! NO LIFEGUARD ON DUTY
- ❖ A Heritage Trails pool fob is required to enter the pool, climbing over the fence or gate is prohibited, Trespassers will be prosecuted – <u>DO NOT ENTER WHEN POOL AREA IS CLOSED</u>
- Only residents of Heritage Trails and their guests are permitted in the pool area. Maximum of four (4) guests per household
- Always keep gate completely closed, Do NOT open the gate for anyone, or prop it open
- NO FOOD OR DRINKS allowed inside the pool
- Persons with contagious diseases, diarrhea, skin abrasions or open infected sores, lesions or wounds will not be allowed in the pool
- Proper swim attire required, no jeans, cut-offs, street clothes or loose clothing allowed for safety reasons, babies / toddlers MUST wear swim diapers
- Use of floatation devices, rafts or toys must not interfere with other swimmers' use of the pool
- Children 16 and under must be always accompanied by an adult over the age of 18
- NO profanity. NO loud music. NO glass containers. NO smoking. NO alcohol. NO drugs
- NO DIVING, PUSHING, RUNNING OR HORSE PLAY ALLOWED IN THE POOL AREA
- No pets allowed in the pool area unless it is a service animal
- No skateboards, bikes, scooters, rollerblades, or motorized vehicles allowed inside the pool
